**YOU CAN REGISTER TO VOTE**

- If you are a citizen of the United States
- If you will be 18 years of age on or before election day

**TO REGISTER**

Mail Registration forms are available at post offices, libraries, municipal buildings and party offices. You may also appear at the Motor Vehicle Boards to register when you renew or change your driver's license. Forms can be accessed by going to [www.dos.state.pa.us](http://www.dos.state.pa.us).

Upon processing your registration form, an acknowledgment notice (ID) will be mailed containing your pertinent registration information and your polling place.

The election law prohibits removal of a voter's name from the rolls simply for not voting. A voter's name may be removed for the following reasons:

- Upon the death of the elector.
- At the request of the elector.
- Upon confirmation that the elector has moved outside the country.
- In accordance with one of the two voter removal programs.

**IDENTIFICATION FOR FIRST TIME VOTERS** — New Federal and State laws require voters who appear to vote in a precinct for the first time to provide election officials with proof of identification.

**PROVISIONAL BALLOTS** — New Federal and State laws provide voters with the opportunity to cast a provisional ballot under certain circumstances. County election officials will examine the provisional ballots within 7 days after an election to determine if the individual voting that ballot was entitled to vote at the election district in the election.

**COMPLAINTS** — A complaint process is now in place for voters who feel that the above requirements have not been carried out properly.

A Voter's Guide entitled Your Vote is Your Voice (in English and Spanish) can be obtained at the Voter Registration Office.

**ABSENTEE BALLOTS** — Any registered voter who is unable to vote at their polling place because of illness or absence from their municipality/county or observance of a religious holiday or must perform election duties, may apply in person, or in writing, to the Voter Registration Office, Municipal Building, Lebanon, PA 17042, to request an application for an absentee ballot. This application must be returned before the absentee ballot is issued. The absentee ballot may be obtained no earlier than 50 days and no later than 7 days before the primary or election days. The ballot must be returned to the County Board of Elections before 5 P.M. on the Friday before the election. Application - go to [www.lebcounty.org](http://www.lebcounty.org)

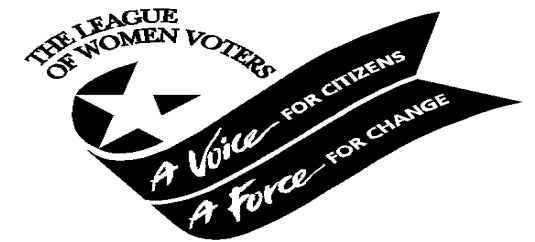
